

October 13, 2017 – Visa Business-to-Business (B2B) Virtual Payments Program

Visa's new B2B Virtual Payments Program in Canada enables online travel agencies (OTAs), travel service providers and other travel payment providers to use virtual accounts to pay their suppliers for inventory. This program applies to select Merchant Category Codes (MCCs), which are listed below. The fees associated with accepting these types of payment are as follows:

October 13, 2017 – Canada Intracountry Debit Mastercard Contactless Assessment Fees

Mastercard will be implementing a transaction-based fee of \$0.004 USD for intracountry debit Mastercard contactless transactions effective October 13, 2017.

Mastercard will be implementing a transaction-based fee of \$0.02 USD for Intracountry Utilities transactions effective October 13, 2017. This program applies for merchants classified under Merchant Category Code (MCC) 4900: Utilities – Electric, Gas, heating Oil, Sanitary, Water.
