<p>How do I activate my Merchant Resource Center account?</p>	<p>Your Welcome email that you received from Moneris when you signed up for your account contains your Merchant ID, Store ID, and an activation link.</p> <p>Click on the link, enter the information provided, create a user name and password in order to activate your Merchant Resource Center account.</p>
<p>How do I enable payments on my website?</p>	<p>Refer to the Moneris® Online Setup Guide for complete instructions to enable Moneris Checkout payments on your Bookmark™ ecommerce website. Visit Moneris Support to download a copy today.</p>
<p>What is the Merchant Resource Center (MRC), and why do I use it with Bookmark?</p>	<p>The MRC is Moneris' secure online portal for transaction processing and management. The MRC is where the integration settings are configured, such as Moneris Checkout, which is the transaction processing engine for your Bookmark ecommerce website. You will use the MRC to perform voids or refunds for purchases that come from your Bookmark ecommerce site.</p>

Using Bookmark's simple interface, combined with AiDA, their powerful artificial intelligence design assistant, you can create a new website in a matter of minutes.

When creating your site, just tell AiDA your business name and the sector you operate in and in 30 seconds, she will come up with a unique design for your website. Then all you have to do is edit your content and images.

For the Merchant Resource Center:

1. Launch a web browser and go to moneris.com/mrc.
2. On the Merchant Resource Center main page, click the **Forgot Password?** button.
3. On the Password Reset page, enter your **User Name** and **Store ID** into the provided fields, then click the **Submit** button.
4. The system emails you a link to click to reset your password. Follow the on screen instructions to create a new password and save it.

For Bookmark:

1. Launch a web browser and go to bookmark.com.
2. On the Bookmark homepage, click the **LOG IN** link.
3. On the Bookmark login page, click **Reset Password**.
4. Enter your email address and click the **RESET** button. The password reset link will be sent to your email.
5. Follow the on screen instructions to create a new password and save it.
